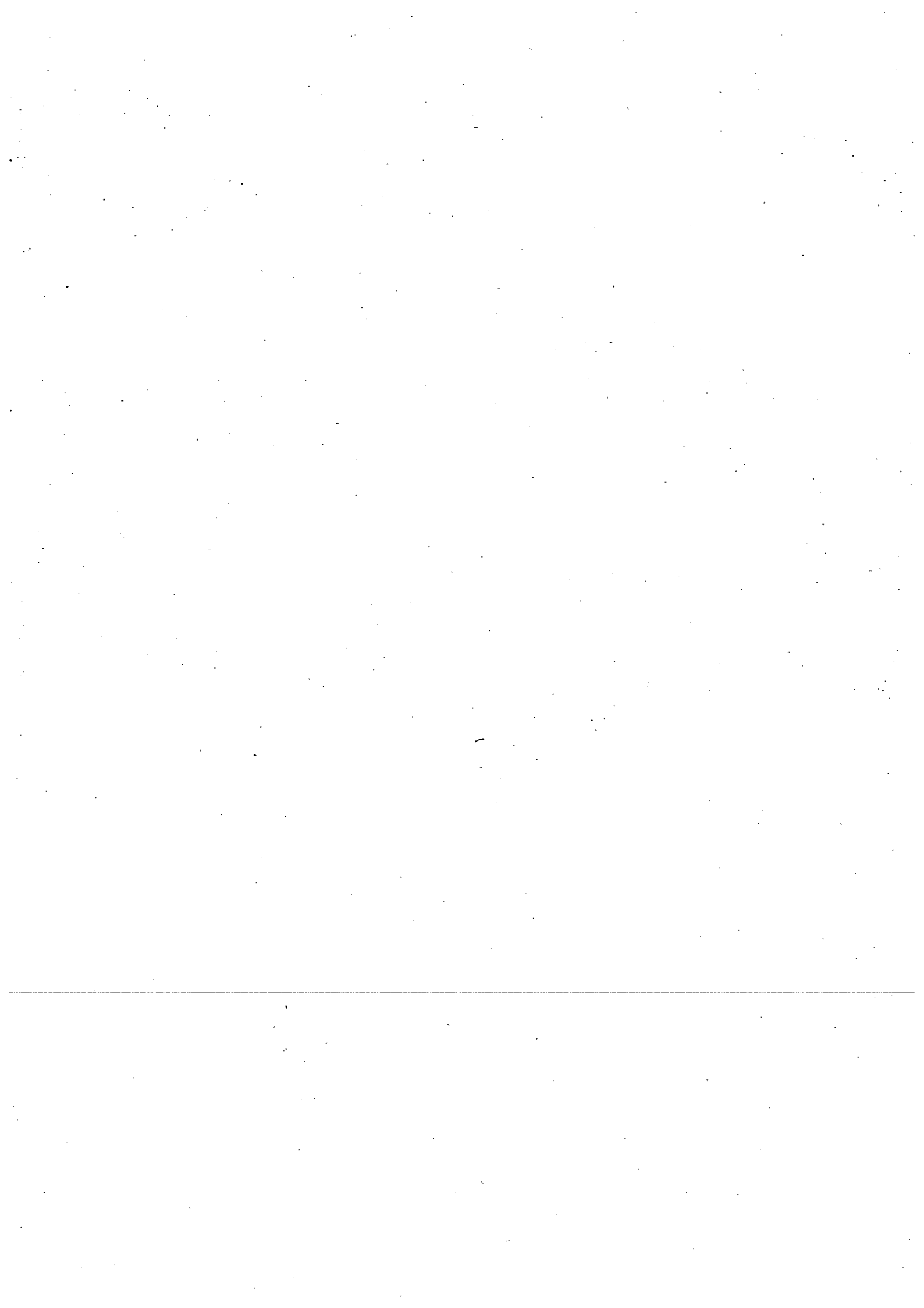

Of the Twenty one (21) tenderers, except two, all have submitted Technical Bid as well as Commercial Bids (two covers). Barring the above two, out of 19 bidders 16 have put the tenders along with the EMD either in terms of DD or in terms of Bank Guarantee and the following 3 tenderers have not given either DD or Bank Guarantee, but have claimed exemption based on the SSI certificates they hold..

1. M/s.Impact Technologies, Chennai
2. United Data Services Ltd, Coimbatore and
3. Megalazers, Chennai.

All the 19 tenderers have furnished the details viz., Region / Regions Opted, Postal address etc., of their office registered in Tamil Nadu. The details viz., individual turnover, previous experience, IT certificate and VAT certificate details produced by them are to be scrutinized in detail.

The participant bidders were informed by the tender inviting authority viz., Chief Electoral Officer & Principal Secretary to Government that the Tender Committee headed by the Addl. Chief Electoral Officer would scrutinize each tender (technical bid) documents submitted by the individual tenderer in detail and if necessary the individual tenderer will be asked to produce required

documents, proofs etc., during the course of the scrutiny. After scrutiny of technical bids, the list of eligible bidders would be finalised and approved by the Tender Accepting Authority. Accordingly, all eligible bidders would be informed of the date and time of opening of the price bids of the eligible bidders. The participant bidders were also informed that they can attend the opening of price bids on the designated date, time and venue.

After this, all the nineteen sealed Commercial bid covers of the bidders who had given their price bids, were put in a separate cover in the presence of the participant bidders and the cover was sealed with wax seal. The willing participant bidders put their signature on the cover containing 19 Commercial bid covers along with the CEO and the Addl. CEO.
